## Notice to Exhibitors

- The building will open at 7:30 AM on Sunday.
- Transfers will be allowed for both the Obedience and Rally trials. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.
- Space is limited. High occupancy x-pens (3 or more dogs) only, and please do not bring "tent" style crates.
- POLICIES REGARDING WORKING ON THE ARTIFICIAL TURF ARENA
  - The following treats may be used on the turf: String cheese and slices of cheese, meat roll (non-crumbling), freeze dried treats, hot dogs, jerky treats, pupperoni, soft packaged treats (non-crumbling)
  - You may not use: Baby food, Braunschweiger, cheese puffs, cooked liver, cooked chicken, ground cooked meats, hard crunchy biscuits, popcorn, raw foods, yogurt.
  - You and your dog are required to pick up the treats from the turf.
  - Please potty your dog often. If there is an accident, there is a charge of \$5 to offset the cleaning of the turf.
  - Waterproof covering is required under crates and set-up areas.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement.

## Directions

From 95 North: Take Exit 50A-50B onto Caton Ave toward South Washington. Keep right onto Caton Ave S toward Washington Blvd. Turn right onto Joh Ave. Turn left onto Benson Ave. Turn left onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

From Interstate 695/Baltimore Beltway traveling towards Essex: Take Exit 11A-11B for Interstate 95 South towards Washington. Keep right and follow signs for Sulphur Springs Rd. Turn right onto Sulphur Springs Rd (signs say Arbutus/Violetville). Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.

From Interstate 695/Baltimore Beltway traveling towards Towson: Take Exit 10 for US-1 ALT/Washington Blvd in Halethorpe. Turn left onto Rt 1, turn right onto Sulphur Springs Rd. Take the first right onto Benson Ave. Take a right onto Knecht Ave. Turn left onto Azar Ct, #9 is on the right.
