- Please be aware that masks may be required depending on conditions in the community at the time of the trial.

### **Entries Open on:**

No opening date

Please make sure your entry is legible and that all required information and correct fees are included. Illegible entries and entries missing info/fees will not be processed and will be returned to the exhibitor. Entries accepted on a first received basis. Please waive signature for express delivery.

### **Entries Close on:**

June 10, 2022

Entries received after closing date are considered day-of-show for pricing (\$15 per run)

### **Crating:**

Indoor crating will be allowed. Waterproof mats/tarps must be placed under crates. Crating space limited. High occupancy x-pens only.

### **Entry Limits:**

350 runs per day

### **Move ups:**

**Pre-trial deadline: 5 pm Wednesday June 15**

At-trial deadline (for Sunday): end of day Saturday.

### **Day of show Entries:**

May be accepted if trial does not fill by closing date

### **Refunds:**

Entries withdrawn due to suspected/actual COVID-19 illness will receive a full refund.

Entries withdrawn before the closing date will receive a full refund.

Entries withdrawn after the closing date due to injury and/or illness (human/canine) and/or a bitch coming into season will be eligible for a refund up to 75% of total entry fee paid. A doctor/veterinarian note of injury/illness will be required for a refund.

No entry fees will be refunded if a dog and/or handler are dismissed from the competition, regardless of the reason. See summary of NADAC rules for other circumstances under which entry fees will not be refunded.

### **Confirmations:**

Confirmations will be sent by e-mail. Please add [artfuldodgersnadac@gmail.com](mailto:artfuldodgersnadac@gmail.com) to your address book to ensure receipt.

Please check ALL information on your trial confirmation as soon as you receive it. This includes your dog's NADAC registration number, jump height, category, division, and level, among other information. Report any errors to the Trial Secretary by e-mail immediately.

### **Food info:**

There is no food vendor on site. Various restaurants and fast food vendors are located within a short driving distance of the site. Some offer delivery.

### **Volunteer info:**

We will have a worker signup board--please volunteer for as many slots as you like. We appreciate your efforts to help us put on a successful trial and will compensate workers with coupons that can be used for future trial entries.

### **Awards and Ribbons:**

NADAC ribbons will be awarded for qualifying runs and to first through fourth places in all jump heights in all classes. Rosettes will be awarded for those finishing a title. Special rosettes are available for NADAC awards (e.g. Triple Superior, Versatility, NATCH).

### JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

## Brief Summary of Rules:

Please refer to [www.nadac.com](http://www.nadac.com) for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted.

- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but you cannot indicate to the dog it is there. All handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

- 1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.
  - 1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
  - 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
  - 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

### SITE INFORMATION & CLUB POLICIES

- **All competitors must follow the COVID-19 safety policies stated in the final confirmation. Any violations of these policies may result in a competitor's dismissal from the trial with no refund.**
- **PLEASE CLEAN UP AFTER YOUR DOGS!** A map of designated areas on site where dogs may eliminate will be sent with your confirmation. Exhibitors who allow their dog to eliminate in prohibited locations or who do not clean up after their dog will be dismissed from the trial with no refund.
- There is no overnight RV parking on site. During the trial, RVs can be parked in the back of the lot.
- We will do our best to accommodate those with special parking requirements; however, you must have the appropriate official parking permit displayed. Please include a note to the Trial Secretary with your entry
- ***Sprint turf requires specialized cleaning. A damage fee for accidents will be levied.***
- No food or beverages (other than water) may be consumed on the sprint turf.
- No cleats of any type may be worn on the turf.
- If indoor crating is permitted, crates may be left overnight. The building will be locked but Artful Dodgers is not responsible for security of personal items.
- Dogs may NOT be left overnight.
- No alcoholic beverages are allowed on the show site.
- All dogs must be on leash when not competing in the ring.
- Dogs must be appropriately crated or penned when not competing or not with their handlers. Dogs may not be left unattended tied to chairs, doors, etc.
- Exhibitors are responsible for being at the ring when it is their turn to run, and to enter the ring when the gate steward indicates. Any dog and handler not present when they are called may be ineligible to run.

Please accept the responsibility for reviewing your results both at and after the trial. Verify that your registration number and qualifying points are correct. If you find an error at the trial, notify the Trial Secretary immediately so the error can be corrected before the results are submitted to NADAC.
