Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test and, in such instances, applicable entry fees will be refunded. At roll call, all dogs will be measured by a wicket to verify handicaps. Bitches in season, lame and unfit dogs will be excused with entry refunded. Please do not bring bitches in season to the test.

Fun Runs:

Fun Runs will be available on Friday and Saturday after the trials end each day. All site rules apply. Fun Run entries will be accepted on site on day of trial only. Females in heat are not allowed on the track.

Fun Run Fee:

\$7.00

Conditions of Entry

Entries will be limited to 80 dogs per event, two events daily running concurrently with rolling check-in and inspection, in a block schedule. Plan to arrive 15-30 minutes prior to your scheduled time block. **This means we schedule dogs to run both Run 1 ("AM") and Run 2 ("PM") events in a single time block.** Each block is generally an hour and allows for a short rest between runs. This is a "show & go" event, we ask that you depart the site when you have completed your runs unless you are available to assist other entrants.

Every dog must pass through inspection before each event. At inspection, all dogs will be examined for general fitness and for bitches in season, which are not permitted to run. Do not bring bitches in season to the site. Contact the trial secretary if your bitch comes in season after the closing date. At inspection, bitches in season, lame and unfit dogs will be excused with entry refunded. **All refunds are subject to a \$2.00 administrative fee per entry.**

During entry, if you include the names of the person releasing your dog, we will attempt to schedule you in the same time block. **Each handler is responsible for arranging their releaser and/or catcher prior to trial start.** When assistance is available, it is a courtesy provided by the volunteers, who accept no responsibility for any actions or consequences. If you are available to assist, please contact the trial secretary.

All entries must be accompanied with payment to be valid. A returned check is not a valid entry. There will be a \$35 fee for a returned check. Entries received by phone, text, or email will not be accepted. Incomplete entries or forms without signature will not be accepted. On-line entry and payment are encouraged.

Dogs must have an AKC registration number and be at least one year of age on the day of the event. Dogs may only run once per event. One dog per entry form per event. Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate.

No refunds for absent dogs. Dogs are considered absent if not inspected 30 minutes after the start of the last time block.

Hours

Grounds will be available by 7:30 AM each day and until all runs are completed or 3pm, whichever comes first. In the event of inclement weather or other conditions or to assist with timely completion of the trial, ODTF may elect to start or end the events earlier or later than posted. Early acceptance of dogs for members of the field committee may begin one-half hour prior to published test hours.

Field Conditions

The field is reasonably flat, level and mowed. The total length of the running area, including a runback zone, is approximately 170 yards long at 5 yards wide, with wire and plastic type barrier fencing using electronic timers and a continuous loop setup. The lure will consist of white plastic bags.

Prizes

ODTC will offer a light blue flat ribbon for a passing qualifying run.

ODTC will have a limited number of title rosettes available. Please notify the trial secretary, via email or include with your entry form, if you will be earning the following titles to ensure that the club will have rosettes available:

BCAT ----- 150 points

DCAT ----- 500 points

FCAT --- 1,000 points

FCAT2 - 1,500 points

FCAT#.....each additional 500 points

What is the Fast CAT?

Fast CAT is a timed straight 100-yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).

FORMULA: $204.545 / \text{RUN TIME} = \text{MPH}$

$\text{MPH} \times \text{HANDICAP} = \text{POINTS (ROUNDED TO NEAREST 0.01)}$

Based on the dog's size at the withers a handicap is applied, and points are earned:

- 18" or greater = Handicap is 1.0
- 12" up to less than 18" = Handicap is 1.5.
- Below 12" = Handicap is 2.0.

MPH X HANDICAP = POINTS

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points

FCAT# = Each additional 500 points

Top 20 by Breed by Year

Trial Site Directions

From Baltimore:

Take I-695 to I-97 South. Exit from I-97 onto New Cut Rd. Bear right off the exit, continue on New Cut Rd and bearing left on to Gambrills Rd. Turn left Dicus Mill Rd. Turn right on to Ski Lane. Hog Dog is at the end of Ski Lane. Follow signs and speed limit restrictions. Park across from the pools and not on the agility field.

From Washington and South: Take I-97 North to New Cut Road

Go East on Rt. 140 and turn right onto 91 South at the light. Follow the directions above.

From Points South:

Take I-70 West from Baltimore, or East from Frederick. Exit onto 32 North at Exit 80. After you pass the main intersection in Eldersburg (Hwy 26, Liberty Rd), you will continue north for 5 miles to the traffic light at 91. Do not turn here, but continue north for 0.3 miles to Niner Rd and follow the directions above.

Parking is available at the Hog Dog Productions site. No cars are allowed on the field itself unless special permission has been arranged in advance. Please make sure you bring any support you need to walk across the grass field to the FastCat course.

Notice To All Exhibitors

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same. All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitor's entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

OTDC Trial Information

- Dogs should be warmed up before and cooled down after running.

- **ALL DOGS RUN AT OWNER'S SOLE RISK**

- All entries must be 12 months of age or older on the day of the test.
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly. Please bring your own shade, chairs and water.
- An electronic timing system will be used. An electric, continuous loop, plastic strip lure machine will be used.
- The show grounds are not completely fenced. The FAST CAT course will be fenced.
- On site bathrooms are available.
- Dogs must be on lead or crated unless running.
- Dogs are not permitted to run while wearing harnesses, choker collars, electronic training collars or head collars. Collars should be snug. Hanging tags pose a safety concern and should be secured to the collar with tape or removed. Dogs may run muzzled if desired.
- Each handler is responsible for arranging their releaser and/or catcher prior to trial start.
- **A \$5 fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.**
- You are responsible for controlling your dog(s) and children.
- Each dog requires an individual entry form for each event in which it is entered.
- Bitches in season and lame dogs will be excused. **Entry fees will be refunded.**
- The Huntmaster is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. In service to this responsibility, he/she has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to the AKC/ODTC/any dog(s)/other person(s) will be asked to leave the trial site by the Field Committee, maybe disciplined by the AKC, and **entry fees will not be refunded.**
- **No entry fees will be refunded** if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or
- The event-hosting club, Oriole Dog Training Club, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.
